- Associations will be billed in two installments - the first billing for league fees and half of the referee fees will be issued mid to late December, and the second billing for tournament fees and the remaining half of the referee fees will be issued around February 1<sup>st</sup>.

**D10 Director - Colleen Donovan**

- **Waivers:** All players have to register with their home association before getting waived out, with the exception of school waivers. Players should have two copies of their USA confirmation number for each association and should not pay home association fees but rather the receiving association's fees.
- **Tier 1 Waivers:** for the 2014-15 season only, the following teams have been granted the before/after with MNH, so any players playing on the listed teams will need a waiver from their home association, even if they are high school players:
  - MN Blades Hockey Club, Youth 16U & 18U, Minneapolis Hockey Association
  - MN Northern Wings, Youth 16U & 18U, Hermantown Hockey Association
  - MN Magicians, Youth 18U, Richfield Hockey Association
  - Bauer-Emerson (Ability Academic & Athletic Teams), Youth 14U, 16U & 18U; Girls 14U, 16U & 19U, North St. Paul Hockey Association.
- Before allowing a player to register who has claimed to move into your association, make sure they did move and are living there and attending school in the said residence. If found out differently, they will be moved back and your Association will be issued a fine.
- **Rest Rule:** The rest rule has changed from three (3) hours to two (2) hours; however, the ten (10) hour rule and two (2) games per day are still in place. Teams may

schedule a practice before or after a game without the two (2) hour rest at the discretion of the coach and Association.

- 2015 Midwest Peewee Tournament of Champions: The Peewee A champion of the MNH State Tournament will be eligible to represent MN in the Midwest Peewee Tournament of Champions to be held March 28-30, 2015 in Sun Prairie, Wisconsin. The entry fee will be paid for by MNH.
- Mites will only be allowed ten (10) full ice games, which will be monitored. The time between activities has been reduced to 1-1/2 hours.
- SafeSport: All coaches, managers, board members, officials and locker room monitors need to complete the required SafeSport training by roster sign-off. SafeSport training is not required for minor officials (penalty box, clock etc.). You can take the training on-line or D10 will be hosting SafeSport training on Tuesday, September 16, 2014, 6:30 PM at the Rogers Arena. If you are planning on attending, please email Colleen at [d10director@yahoo.com](mailto:d10director@yahoo.com) and let her know. Coaches attending will need to bring their CEP number.
- D10 will be hosting the Squirt/10U year end tournament March 6-8, 2015. The tournament will consist of teams from Districts 3, 5, 6, & 10. The top two (2) teams from each level will advance to the tournament.
