**Minutes of Last Meeting**

**D10 Treasurer - Roger Sundeen**

**D10 Director - Colleen Donovan**

- Rosters/Team Registration: Please note the following items that should be completed before roster sign-off:
  - Coaches CEP - will be listed on the rosters
  - SafeSport completion - will be noted on the rosters
  - Background screening will not be on the rosters this year. Check your coaches, board members and anyone else that is around the kids to make sure they have completed the background screening. Background screenings are required every two years, which the Associations need to keep track of and ensure completion when due.
  - Any ineligible players will be red-lined.
- Sport Ngin: Associations should inquire about the fee they are being charged for using credit cards. They currently charge \$1 per transaction/player plus a percentage. If the percentage your Association being charged is more than 2.75%, call and ask for a reduction in the fee.
- MN HS Rule 411: The MN HS Rule 411 has been passed. HS teams cannot play non-members. Associations that have done this in the past will need to check with their school's AD to get a waiver. (Example - 14U playing HS JV).
- SaveSport: D10 Board of Directors need to complete the SafeSport training and send Rhonda your certificate of completion by roster sign-off.

- There is a new MNH "progressive penalty" rule. Any player who receives their third major penalty during the same season for any combination of aggressive infractions listed below shall receive an additional three-game suspension. For any player who receives their fourth major penalty in this category, the player shall receive an additional five-game suspension. Any player who receives their fifth major penalty in this category during the same season shall be suspended until a hearing is conducted by the proper authorities (USA Hockey Affiliate). These designated game suspensions shall be in addition to any other suspensions imposed through the official playing rules.
