- Head Coach & Managers information was due today. League games start Monday, November 9<sup>th</sup>.
- Thanks for all the help at Roster signoffs with Becky Ewing and Colleen Donovan. Helping on Saturday was Jason Waldowski, David Englund, Bruce Erickson, Bruce Carlson, and Jeff Piehl.
- PLEASE make sure you thank your registrars for all the work they put in chasing down coaches, volunteers, and parents to get ready for roster signoffs.
- Schedules have gone live for league play, which also means league rescheduling has begun. League play begins on MONDAY 11/9 This may prove to be a challenging year with rescheduling. I would ask for patience and understanding with the process as we navigate any disruptions due to COVID.
- Reminder to all to be careful with social media.

**D10 Director - Colleen Donovan -**

- Many emails and issues with COvid guidelines
- If a person tests positive, you must quarantine for 14 days
- Each case will have to be handled on a case by case basis.
- Coaches are bringing in a doctor's excuse, for not having to wear a mask. We will accept excuse for practice on the ice, but coaches MUST wear a face covering on the bench, or they can not be on the bench
- Minor officials – We to check on rinks, access to the box, some rinks have challenges and for those (Anoka rink1, Champlin), that will allow 3 people in the penalty box.
- Fighting – if a player is written up for fighting, its an automatic 3 game suspension, if the player is caught in a second fight instance, they will be done for the year.
- MITES- ADM model, please remember - currently allowed 2- 25 pods on the ice (which includes the coaches) for a total of 50 people on the ice.

- Safe Sport is STILL in effect, and so are locker room monitors. If players are in the locker room, someone must be there as a locker room monitor. We must go back and make sure coaches and parents are following these rules.
- **SCRIMMAGES:** Effective immediately, to protect D10 players, coaches and reach the goal of having District tournaments in February, it has been decided by the D10 Executive Board to not allow any scrimmages after December 1<sup>st</sup> 2020. We will not stop teams from scrimmaging with other teams in other districts. We may look at turning it around if things with Covid improve.

CLARIFICATION: D10 will not schedule or supply a ref for any scrimmage in D10 boundaries Or for D10 teams) after 12/1/2020. D10 teams can schedule a scrimmage outside of D10 if they choose too.
