## D10 Supervisor of Officials - Mike Mannin

- 1<sup>st</sup> seminar for youth referees was on 9/10, 57 kids total, 50 were from D10. Will have additional clinics on 10/15 in Fogerty & 11/5 in Rogers
- Mouth guards are mandatory
- No pucks on the ice until the nets are set.
- There will be four coaches' meetings. Mandatory for all head coaches except Mite & Jr. Gold. Association will be fined \$500 and head coach will be suspended for three games if they do not attend the meeting.
- Out of district teams mandatory attendance for coaches' meetings also.
- Exhibition games are no longer "scrimmages" using the same wording as MN Hockey & USA Hockey
- Controlled Scrimmages no clock, no score, no time each team must have 1 coach on the ice. Request form for controlled scrimmage must be sent to Mike M & Colleen to approve for tracking purposes. Head coach will fill out, needs 2 day lead time, Form on D10 website under the referee tab. Will not count as a game
- Video will not be used to watch disputed calls except for match penalties or if wrong player number is given for a game misconduct.
- Only the Head coach can file a complaint about a referee.

• Mites & 8Us can leave the district for controlled scrimmages with approval from Colleen.

## Game Schedule/Declarations - Tom Nergard

- For tryout scrimmages, associations can pay for referees, penalties will be called & players will sit in the penalty box.
- Scrimmages will be added to game sheets for exhibition season, will need to have a roster of players on the ice & team coaches. Sind this to Becky.
- Invitational Tournaments Colleen will sign of on them. Send brackets & schedules to Tom for referees. Make sure to send them with enough lead time.
- Final Team declarations 10/2.
- There will be 3 referees on the ice for Bantam games and 4 for Jr. Gold.
- 10UB2 need 5 teams to have a level in District 10.
- Rescheduling fees have gone up.
