Associations missing Membership Meetings

\$250 per Association

Coaches missing Mandatory Coaches Meeting

For Squirt/U10 through Bantam/U15 (all levels AA,A,B, C)

- a. 1 coach misses meeting **\$500** fine is assessed
- b. 2 – 5 coaches (from same association) miss fine increases by \$100 for each coach, not to exceed \$900 total fine.
- c. 6 or more coaches (from same association) miss, a maximum **\$1500** fine will be assessed
- d. Dates, times, locations for all meetings are in the Activity Schedule.

NOTE: Scores will only be posted on District 10 Website at a (6) six goal differential (per page #30 of handbook) Always send actual final score.

****At the conclusion of a game, the HOME team has 48 hours to complete the Score Report and submit it via email to the D10 Scorer.**

If a team is late or misses reporting the score (via the process), D10 Scorer will contact the League Coordinator who will reach out to the Team Manager or Coach to get the form completed and submitted. D10 Scorer will report to D10 Treasurer that a team did not meet the score reporting time line and is to be fined as follows: (this is per team)

- **\$ 50.00** fine for each late reported score.
- **If D10 enters the score the fine will be \$ 100.00**

NOTE:

This list does NOT include game re-scheduling fines. Please see that policy for details on that.



- Squirts & Girls 10U going to game cap of 35 games season limit \$ 1,000 per game over limit.
- Playing a game or scrimmage against a non-Authorized team – per USHA and MNH Rules \$ 500 per game first offence – second offence \$1,000 – third offence determined by Director.
- Using players not on official team roster to play a game or scrimmage is a violation of MNH Rule V. ELIGIBILITY PROVISIONS: Any team found to have an ineligible player that participates in any MNH game, exhibition game or controlled scrimmage will be suspended from MN District, Region and State play for the current season. The Head Coach of a team that knowingly plays and ineligible player, as a minimum, be suspended from coaching for the remainder of the season. These suspensions me be reviewed by the cognizant District Director to determine if the severity of the suspension is appropriate, and a less severe penalty may be imposed if the facts so dictate. The team will be fined \$ 1,000 First Offence, \$ 1,500 Second Offence, Third Offence to be determined by the Director. The above penalty issued per above MNH Rule Violation. Per D10 if Association Board gave approval the Association will also be fined \$ 1,500.
- Playing a game or controlled scrimmage against a team that is a different classification that is not the right level of play without District Director approval is \$ 500 first offence – second offence to be determined by the District Director.
- Rest rule not following MNH rule – first \$500, second \$1,000, third \$1,500.
- Suspended or non-rostered coaches in bench area first \$ 500, second \$ 1,000, third \$ 1,500.
- Teams playing out of STATE without District Director approval first \$ 500, second \$1,000, third \$ 2,500.
- Mite & Girls 8U playing out of district without approval \$300 per event.
- Mite & Girls 8U playing over the limit of full ice games allowed per District 10, \$ 500 per event.
- Not having a certified locker room attendant always at the locker room a fine of First offence \$1000, Second offence \$2000, Third offence \$4,000 and meet with the District Director. These fines are Association based and are the responsibility of the association.
- Early roster sign off \$ 100 per team.

The above fines, along with the fines listed in the D10 Handbook are based on a minimum and can be more depending on the incident and final District Director review.

Associations responsible for all teams, parents, and players fines and if not paid in full by end of season play are not eligible for post season play.

Outstanding fines at the beginning of the subsequent season must be paid before an Association teams will be eligible to start league play.

Other fines can be assessed to associations if violations are reported to D10 and D10 is able to verify that violation.
