Items from the Floor

- Colleen - Reminder that teams in Squirt/10U level must come in at 35 games if playing after tournaments. The limit goes through 3/17/25.
- Learn to play programs - do they need to be rostered? Put together rosters with signoffs. Players must be within association boundaries.
- Early scrimmage rosters to Becky & Colleen.
- Centennial would like a 19U team. Contact Colleen if there is interest.
- New Rule - No Head Coaches with wife as team manager pairs allowed. In small associations it negates coaching / manager opportunities for DIBS.
 - A Skills Roster Coach for multiple teams can have a spouse as a team manager.
- Locker Rooms - good job collecting phones & having locker room monitors
- Tryout Scrimmages - refs will call penalties even if the coaches request them to allow players to continue without serving penalties.
 - Jeff Z. is trying to put together an exhibition season on Game Sheets
- Full Ice Mite game discussion.
 - If all D10 Associations field a Squirt A team, then the Director will allow for 10 Mite full ice games.
 - USA Hockey is allowing for up to 10 Mite full ice games in MN, but is leaving that up to the district directors.
 - Shared practices vs controlled scrimmage discussion. Can controlled scrimmages happen at the Mite level? After 1/15. D10 Form must be filled out.
