- All disciplinary hearings are held on the 1st and 3rd Wednesdays of each month at the Anoka Arena in the D10 Boardroom.

There must be a minimum of 13 skaters at the tome level. Teams that play 90 minute length games must be a minimum of 14+1.
 - o If a waiver is requested, all tryout scores for that level must be submitted.
