Minutes of Last Meeting

- Motion was made, seconded, and passed to approve the minutes from the October Membership Meeting.

D10 Treasurer - Rhonda Madsen

- Overview of current checking account status. Motion was made, seconded, and passed to approve the treasurers report.
- League invoices will be sent out within 2 weeks and will include any fines up to date and game sheet fees.

D10 President - Scott Meyer

- Head coach and managers information is due today. League games start today, November 3rd.

- Review the tryout process for traveling teams for issues or refinements for next year. A few comments have come in regarding tryout evaluation process.
- We are already receiving reports on Locker Room monitoring not being followed.

D10 Director - Colleen Donovan

- March 7-8, 2026 - Super Series Championship Tournament
 - Districts 1, 3, 5, & 10
 - Hosting Sites: D1 12UB2, D3 Peewee C, D5 Peewee B2, D10 Bantam B2
 - D10 Level Coordinators will need to check with all their teams, if they would accept the invite for their level.
 - The top 2 teams from the D10 Tournament will move on to this tournament.
 - Cost of the Tournament is \$800/team, and no gate fee.
- District 10 is posting a policy on the ;D10 website about ice time for league games and leaving the ice after their allotted time is up. Please inform your coaches and managers.
- USA Hockey Policy - Registered Member is a person who has completed the proper registration process with their local program.
Registered team participants in a sanctioned/approved game or practice will be made up of players and coaches listed on and approved USA Hockey registration form.
2025-26 teams can have 5 coaches + 3 student coaches on the roster but only 4 on the bench during a game or scrimmage. A student coach would count as one of the 4 coaches.
- Locker Room Monitors: At the last meeting, Becky and I explained the USA Hockey policy. Since then I found MNH policy is more strict then the USA Hockey policy, so we will have to follow MNH. Please send your teams a copy of the MNH policy. (handout was available at the meeting).

D10 Mite Director - Dave Englund

- Champlin added an 8UB team today, November 3rd. Deadline was October 18th.
- Out of 150 teams 40 are going to tournaments that need early roster sign off.
- Jamborees can run until March 15th.

D10 Registrar - Becky Ewing

- 40 mite teams is over 25% more than normal for early roster sign off.
- Mite roster sign off is the first Saturday in December and we can not move it any earlier.
- Other roster sign offs went well.
- A number of registrars are resigning next year due to the Boards and being treated poorly by coaches and others.
